# CENTRAL STATES ANTHROPOLOGICAL SOCIETY ANNUAL BUSINESS MEETING MINUTES MILWAUKEE, WISCONSIN APRIL 17, 2004

Item 1. President Paul Durrenberger called the meeting to order at 12:40pm. President Durrenberger welcomed everyone to the annual meeting, particularly new officers.

## Item 2. President's Report.

President Durrenberger summarized the 2003 annual report to AAA, highlighting the recommendations CSAS has made to the AAA Section Assembly and Executive Board regarding consideration of living wage ordinances and union facilities when selecting national meeting sites. President Durrenberger relayed to the membership the discussions of the Board regarding CSAS withdrawing from AAA, and that the Board decided to remain a section for the near future. President Durrenberger also informed the membership of the current efforts to create an institute on public policy. A call for support has been made and President Durrenberger called for the members to contribute financially to the cause. A "hat" was passed for immediate donations. A total of \$425 was collected during the meeting. The funds will be placed in our general account until an organizing committee formally is established. The membership was also informed of the current efforts to have ethnography and ethnohistory research projects be exempt from IRB review.

### Item 3. Secretary's Report.

Secretary J. Lucke summarized the minutes from the April 2003 Business meeting in Louisville, Kentucky. The motion was made to accept the summarized minutes; the motion was seconded and passed by voice vote.

#### Item 4. Treasurer's Report.

Treasurer J. Lucke provided the figures from the most recent statement provided by AAA. See attached report. The motion was made to accept the treasurer's report; the motion was seconded and passed by voice vote.

#### Item 5. 2004 Program Chair Report.

Outgoing First Vice President R. Feinberg reported on the success of the current meeting citing twenty-four sessions with over 150 presentations made. Registration was 225. Vice President Feinberg thanked P. Gray for his work in local arrangements, and everyone who organized a session. Distinguished Lecturer Andrew Strathern and the University of Wisconsin-Milwaukee were thanked for a successful Friday evening event. Everyone is encouraged to attend the Saturday evening jam session and tickets are still available for the Sunday morning breakfast. A motion was made to accept the report of the First Vice President; it was seconded and passed by voice vote.

## Item 6. First Vice President's Report.

Incoming First Vice President P. Gray J. Gray thanked the staff of the Park East Hotel for making the meeting a success, particularly Amy and John. He also announced the 2005 annual meeting would be held in Oxford, Ohio on March 10 to 12 at the Marcum

Conference Center on the campus of Miami University. Local host will be J. Hamill (Miami University). A call was made to submit paper and session proposals by the December 1<sup>st</sup> deadline. As the 2005 meetings are one month earlier than usual, please have all proposals submitted by the deadline. Plans for a CSAS jam session are also being made for any musicians or vocalists who may attend. A motion was made to accept the report of the First Vice President; it was seconded and passed by voice vote.

A call for ideas for sessions for the 2005 AAA annual meeting was made as well, with the reminder that it is never to early to begin planning. Please let P. Gray know of your interest by late October 2004.

# Item 7. Second Vice President's Report.

Incoming Second Vice President MC. Hopkins announced the 2006 annual meeting would be held in Omaha, Nebraska in April. Local host will be Barbara Dilly (Creighton University). Any suggestions for the annual meeting should be forwarded to MC Hopkins and B. Dilly. A motion was made to accept the report of the Second Vice President; it was seconded and passed by voice vote.

Archivist. P. Sandstrom updated the progress on collecting and processing of CSAS papers for the National Archive. A motion was made to accept the report of the Archivist; it was seconded and passed by voice vote.
