Leslie A. White and Beth Wilder Dillingham Research Awards

The Central States Anthropological Society announces with pleasure the two winners of our 2007 student research awards. Each year, CSAS makes several competitive awards available to graduate and undergraduate students; two of these grants are in honor of past leaders of CSAS, Leslie A. White and Beth Wilder Dillingham. This year our award winners are Anna J. Willow and Bronwyn Nicole Fullard. Anna J. Willow, a graduate student at University of Wisconsin-Madison, is the winner of the Beth Wilder Dillingham Award for her research on the Grassy Narrows First Nation Anishinaabe in Ontario. She will use the award to cover child care expenses and also to help the cost of returning to her field site for a week. Bronwyn Fullard, a junior at the University of Notre Dame in Indiana, is the winner of the Leslie A White Award, and will use the funds to help toward the cost of her continuing fieldwork on AIDS in Kenya. Ms. Fullard is investigating the reasons why the population has not been using the anti-retroviral drugs that are available free in the local drugstores. Congratulations to both Ms. Willow and Ms. Fullard for their excellent projects and congratulations to their mentors for supervising such interesting and important work. Leslie A. White and Beth Wilder Dillingham Research Award Competitions for 2008

The CSAS periodically confers two scholarships, the Leslie A. White and the Beth Wilder Dillingham Award.

The Leslie A. White Award was established in 1983 by the estate of Raymond L. Wilder, the father of then President Beth Wilder Dillingham, a doctoral student of White. Dr. Wilder had wanted to establish a memorial fund for White but was unable to do so before his death. His wishes were made manifest through his daughter. The award was established in honor of White's contributions to the CSAS and to anthropology. The award is meant to assist young scholars (graduate or undergraduate) in any subfield of anthropology with research expenses.

The Beth Wilder Dillingham Award was established in 1989 by Mrs. Una G. Wilder and Clay Dillingham to honor Dillingham's commitment to the CSAS, to the discipline and to aiding young scholars (graduate or undergraduate) with dependent children. This award is meant to reflect one of Beth Dillingham's major concerns-the difficulty of building an academic career while raising children at the same time. Therefore it is the spirit of the award to assist graduate or undergraduate students in any subfield of anthropology who are responsible for the care of one or more children.

"Young scholar" does not refer to the chronological age but rather the "academic age" of the applicant; they cannot be an established scholar in the field of anthropology but be working toward their degree--thus "young" in the discipline.

The 2008 application deadline will be April 11, 2008. Application forms will be available on the CSAS Web Site. Award amounts vary each year. Check announcements for amount to be awarded.

Student Paper Competition (Undergraduate Division)

The paper, "Migration, Diffusion, Emulation: Petrographic Analysis of Transcaucasian Pottery from Malayta, Turkey", by Katherine Erdman of Grand Valley State University, is an outstanding example of original and relevant research carried out by an undergraduate. The author starts with a contemporary archaeological problem: What explains the presence in Malayta (Turkey) of red-black pottery typical of Early Transcaucasian Culture (ETC)? She used petrography (the analysis of mineral content in clays using different wavelengths of light) to compare ETC red-black pottery and locally made wares. She examined twenty-seven sherd samples from several sites and used cluster and factor analysis on the data gathered. ETC-style sherds and local-style sherds appear to have similar mineral and clay composition. Therefore, there does not appear to have been a large movement of vessels from Transcaucasia through migration or long-distance trade but rather local potters were emulating ETC ceramic style using local materials. Throughout the paper, the author shows great familiarity with the archaeological issues as well as with the technical aspects of her research. She includes figures that display the scatterplots and dendograms that support her conclusions. All in all, it is an excellent research paper that well deserves the 2007 CSAS undergraduate paper prize. (Note that there was no Graduate Student Paper award in 2007.)

Attention all CSAS Members! Graduate and undergraduate student members of CSAS are invited to submit papers for the 2008 annual meeting and to consider submissions for the annual student paper competitions. Faculty and professionals should identify and encourage promising student projects and papers. To be entered in the contest, a paper must first be presented at the annual meeting and then sent to the Second Vice President, who will chair the panel of judges. CSAS sponsors two awards, one each for graduate and undergraduate papers. The deadline is generally two to three weeks after the CSAS conference to give students time to revise their papers using feedback gathered during presentation at the conference. PRE-REGISTRATION FOR CSAS 2008 IS DIFFERENT THIS YEAR

This year we are encouraging *everyone* to submit abstracts and fill out registration forms on the CSAS website <http://www.creighton.edu/csas>. Pre-registration fees, however, must be mailed *separately* to the CSAS Treasurer either by check or by credit card (see registration form for address). Note that CSAS can only accept MasterCard and Visa cards. Abstract submission and pre-registration forms are printed below. They will also be available on the CSAS website as well as from the Secretary/Treasurer. A separate form should be completed for each person registering.

If you are not able to use the CSAS website to submit your abstract and registration forms then you may use the forms included in this Bulletin but please make sure to send your *abstract and session proposals* to Claude Jacobs, 2008 CSAS Program Chair, and your *registration form and fees* to Harriet Ottenheimer, CSAS Secretary/Treasurer. Addresses are provided on the appropriate forms. We will be ready to accept your registrations and abstracts beginning November 1, 2007.

Papers that are proposed as part of an organized session should be sent first to the organizer of that session who will then submit them as a package online (or by post) to the Program Chair. Graduate and undergraduate student members of the CSAS may submit paper proposals but these require the signature of a sponsoring faculty member. File the abstract online and ask your faculty sponsor to (e)mail a confirmation note to the Program Chair. Individuals do not have to be members of the CSAS to present papers; however all proposals must be accompanied by registration forms and fees for the presenter(s). **All papers are limited to twenty (20) minutes. The deadline for proposals and for pre-registration is December 14, 2007.**

Pre-registration fees must be paid by December 14, 2007 but should *not* be paid before November 1, 2007. Please remember that proposals for papers and organized sessions cannot be accepted unless pre-registration fees have been paid for all presenters. Session organizers should be sure that all registration forms are filled out for all presenters in their sessions. Session organizers should collect checks or MasterCard/Visa credit card numbers from all presenters in their sessions and send these as a package to the CSAS Secretary/Treasurer, indicating which check or credit card goes with which presenter.

Registration will be possible at the meeting site; however, all persons presenting papers at the meeting must pre-register and pay the pre-registration fees.
