

**Minutes of the Business Meeting of the  
Central States Anthropological Society**  
**Saturday, April 4, 2009 Room 314, Illini Union, Urbana-Champaign, IL**  
Approved April 10, 2010

**CALL TO ORDER**

President Jacobs called the meeting to order at 12:50 p.m

**PRESIDENT'S REPORT** – Claude Jacobs

Dr. Jacobs welcomed everyone to the meeting and introduced the new officers who were present. He also announced that the bylaws change had been approved, making all past presidents honorary members of the Board of Directors and changing the title of Past President to Immediate Past President.

Dr Jacobs recognized the 2008 CSAS Award Recipients as follows:

White award: Antonie Dvořáková, University of Chicago

Dillingham award: Brandi Janssen, University of Iowa

Graduate Student Paper award: Audrey Ricke, Indiana University

Undergraduate Student Paper award: Chelsea R. Iversen, Saint Mary's College

Dr. Jacobs noted that Audrey Ricke was present and thanked her for attending the meeting.

Dr. Jacobs reported on actions taken by the Board of Directors at its Thursday evening meeting:

Rick Feinberg has been appointed to the position of Section Assembly Representative.

Amber Clifford-Napoleone has been appointed to the position of Bulletin Co-Editor.

Alice Kehoe will continue in the position of Bulletin Co-Editor.

The position of Student Representative on the Board of Directors is still open; interested students are encouraged to contact board officers to inquire about a possible appointment.

The board has approved the establishment of a joint membership fee for couples who are both CSAS members. In such cases, the second member would pay 50% of the full membership fee.

The board is working on increasing membership and publicizing CSAS and invites interested people to join this effort.

There will several CSAS-sponsored sessions at the Philadelphia AAA meetings, including invited sessions cosponsored with the Society for the Anthropology of Work and the National Association for the Practice of Anthropology, plus two sessions to be cosponsored with the Association of Latina and Latino Anthropologists. CSAS will also sponsor a round table organized by the University of Illinois at Urbana-Champaign. Members are encouraged to look for these sessions at the AAA meetings in the Fall.

Dr. Jacobs turned the podium over to Alice Kehoe for the presentation of two special testimonial awards. Kehoe presented distinguished service testimonial certificates to Drs. Bernice (Bunny) Kaplan Lasker and Justine Cordwell, in appreciation of their service to CSAS. [Copies of certificates attached to minutes]

**SECRETARY'S REPORT** -- Harriet Ottenheimer

The minutes of the April 2008 business meeting were summarized and approved.

### **TREASURER'S REPORT** – Harriet Ottenheimer

At the at end of 2008 CSAS had 15,641.46 (up from 9,268.70 at end of 2007); the White award fund was up to \$17,512.71 (\$500 was awarded in 2008), the Dillingham award fund was up to \$16,220.56 (\$500 was awarded in 2008). ### **FIRST VICE PRESIDENT'S REPORT** – Margaret Buckner

The 2009 conference hosted by the University of Illinois at Urbana-Champaign had 211 papers organized into 45 sessions. Thanks were offered to University of Illinois – Urbana-Champaign, and in particular to Melinda Bernardo, Stephen Leigh Virginia Dominguez, Norm Whitten, and the entire Department of Anthropology, celebrating its 50<sup>th</sup> anniversary. Thanks were offered to Claude Jacobs, Harriet Ottenheimer, and William Wedenoja for organizational assistance.

### **SECOND VICE PRESIDENT'S REPORT** – Robert Ulin

Dr. Buckner announced that Dr. Ulin's plane had been delayed and that he would not be able to attend the meeting. He reported that the 2010 meeting would be held at the Pyle Conference Center, Madison, WI April 7-11, 2010, and that the Distinguished Speaker will be Neil Whitehead. Dr. Ulin will be Program Chair. Dr. Buckner encouraged everyone to organize panels for the conference.

#### *ARCHIVIST'S REPORT* – Pamela Sandstrom

Sandstrom reported that CSAS papers continue to be archived at the National Anthropological Archives. The CSAS website has links. Each past president is encouraged to send her their papers as they leave office.

Sandstrom brought up the issue of the color of the CSAS logo. She and Cordwell have noted that representing the hand in red on CSAS stationery and other documents appears to be incorrect. The color should be a mica color. She suggested that we formally move to change the red to mica on all CSAS publications. This was approved.

Sandstrom also noted that there have been requests for earrings that hang differently and for an alternative version of the large hand pin without the CSAS letters. Cordwell will talk to the artist about the possibility of these changes.
