# List any factors you think may be increasing or decreasing your Section membership.

As of February 2014, we had 235 members. Our membership fluctuates over the course of the year, peaking during our annual conference. Although it may be premature, our membership seems to be finally trending upwards. The possible ramifications of being one of the smallest sections in the AAA concern us and we are making every attempt to grow. We are using Facebook pages, conferences, awards, our webiste and other means to make the section more attractive. In addition for the last couple of years we have offered free membership (paid for by CSAS) to students who are already AAA mambers upon request. We are attempting to offer a similar deal to members of the Association of Senior Anthropologsts but that process is being delayed until they reciprocate for seniors in the CSAS.

As has been noted on previous reports the cost of AAA membership and the proliferation of sections are making it more difficult for the CSAS to compete for members despite our low annual fee. If one attends our annual conference, the member discount on registration offsets our annual membership fee then membership in the CSAS (assuming prior

# List any factors you think are affecting your Section's finances.

This year CSAS saw an increase in our net assets of \$4,199.32. This resulted partially because our annual conference in St. Louis realized a profit of \$2,661.87. This success occurred despite our awards being financed from the general fund and our continuation of budgeting \$2000 to assist with conference travel for officers and student board members. The White and Dillingham awards are extreemly close to their target budgets of \$20,000 each at which point these awards will begin paying for themselves.

# List spring meeting activities

The CSAS annual conference was held at the Crowne Plaza Hotel in St. Louis, Missouri from April 4-6, 2013. There were 37 paper sessions with 130 papers presented, a poster session with 7 posters and 15 special events such as workshops, field trips, exhibits, and round table discussions. Our distinguished lecture was delivered by Pascal Boyer and was entitled "The Naturalness of Social Institutions: How Human Evolution and Cognition Explains Patterns of Human Society." It was followed by a reception with Greek line dancing provided by the University of Missouri, St. Louis. We held our executive board meeting and annual business meeting at the conference. We had a total of 265 registrations including 14 vounteer and complimentary registrations. It was a highly successful conference. The conference realized a net income of \$2661.87.

# Mentorship:

Our awards (see above for list of winners) are geared to recognize student achievements and provide financial assistance. The Leslie White Award was established to facilitate student research and publishing in any subfield of anthropology. In addition, we have both graduate and undergraduate paper awards. Our Executive Board currently has two student members, who gains experience in organizational governance through interaction with professionals. We offer half-price membership dues for students, and a student rate for our annual conference; as noted above. We have continued a policy of free CSAS membership for students who are members of AAA on request. Our conference is known as highly welcoming to students both undergraduate and graduate, and we encourage our professional academic members to recruit students for the conference. This year our annual conference
