# List spring meeting activities

Our 93rd Annual Meeting was held at the Bloomington-Normal Marriott Hotel and Conference Center from Thursday, April 10th through Saturday, April 12th, 2014. It was hosted by the Department of Sociology and Anthropology at Illinois State University, and the Program Chair and Local Contact were faculty members Jim Stanlaw and Nobuko Adachi. There were 189 paper submissions, 11 posters, five workshops, and 40 panels (a dozen of them organized), representing an increase over most previous years. There were also a dozen faculty members volunteering to be discussant for student panels which added to the level of professionalism. The plenary distinguished lecture for the annual meeting was given by Michael Silverstein, one of the most eminent anthropologists and linguists working today. He is the Charles F. Grev Distinguished Service Professor of Anthropology, Linguistics, and Psychology at the University of Chicago, His talk was titled *Standards*, Styles, and the Semiotic Work of Culture. There was an AnthroBowl contest for the students, and barn dance with music provided by Dave and Dan, two of the area's stalwart acoustic musicians. An Indian music extravaganza was provided by the Nrityamala Dance Academy and Dr. Uma Vyjayanthimal and Murthy Mridangam. We had 267 registrations. It was a successful conference. The conference realized a net income of \$1,794.75

Our awards (see above for list of winners) are geared to recognize student achievements and provide financial assistance. The Leslie White Award was established to facilitate student research and publishing in any subfield of anthropology. In addition, we have both graduate and undergraduate paper awards. Our Executive Board currently has two appointed student representative members, who gain experience in organizational governance through interaction with professionals. We offer half-price membership dues for students and a student rate for our annual conference, as noted above. We have continued a policy of free CSAS membership for students who are members of AAA on request. Our conference is known as highly welcoming to students both undergraduate and graduate, and we encourage our professional academic members to recruit students for the conference. This year our annual conference included several sessions directed at students, including four workshops on professional development for graduate students and junior faculty. This year a workshop at our annual meetings specifically designed for fostering mentoring activities has been proposed by some Executive Board members

# What Initiatives does your Section have underway or planned for the coming year: membership, publication annual meeting, mentorship, other?

The preliminary program of the 2015 annual meeting of the CSAS has been posted online. Next year's Central States Meetings will be held at the Crowne Plaza Hotel in St. Paul, Minnesota from April 9 to 12, 2015. The University of Minnesota, Minnesota State University, Macalester College, and the Science Museum of Minnesota will be hosting the meetings. Willie McKether will be the program chair for the meetings and William Beeman is local contact. We look forward to an excellent conference.

The CSAS archival collection, housed at the National Anthropological Archives (NAA) facilities in Suitland, Maryland, which is administered by the Smithsonian Institution, has been updated by the CSAS archivist, Pamela Sandstrom. The deposit conforms to the January 2012 NAA directive that seeks to recover the costs from AAA member sections for processing of the papers of past presidents, official secretary-treasurer reports, publications (CSAS Bulletin, meeting programs), and other materials of historical interest (officer nominations, student paper prizes, White and Dillingham scholarship awards, etc.). Three full boxes of CSAS materials (about 3.33 linear feet) were delivered by Dr. Sandstrom on November 7, 2014, supplementing the 6.67 lineat feet already being held in the NAA.

We are currently considering some changes to the *CSAS Bulletin* breaking it into small component units with the intent of making the information more timely and productive for the members. We are also working on a membership agreement with the Association of Senior Anthropologists.
